Addendum

Following para is added in continuance of the Academic Regulations 2024-25 of Jigyasa University, Dehradun in order to remove the difficulties in finding student count at a point of time: -

33. (c): DE-REGISTRATION AND RE-REGISTRATION IN A PROGRAMME

- i. When a student is allowed to withdraw temporarily, then such student will be called de-registered student.
- ii. If a student either (a) does not pay semester fee on time, or (b) does not complete semester registration on time, then he/she will be de-registered from the programme.
- iii. If a student either (a) does not complete attendance or other requirements mandatory for appearing in the semester examination, or (b) does not appear in the examination, then such students will be treated as de-registered. However if he/she is eligible for promotion as per Condition for promotion and he/she continued for next semester registration by fulfilling the promotion criteria and by paying semester fee, then such student will not be de-registered.
- iv. A de-registered student may re-register in the programme by way of paying Rs. 5,000/- (Rupees Five Thousand only) as Re-Registration fee and other fee as per the university rules.
- v. Claim of any refund of the annual fee or other fee paid to the university for the concerned academic year will be not be entertained.
- vi. A de-registered student, after re-registration to the programme / semester shall governed by all the regulations of the university and the university fee structure in force at the time of his/her re-registration.
- vii. A de-registered student may be allowed for re-registration within a period of two academic year, after de-registration, subject to maximum to programme completion duration. If re-registration is not done in this period, then the de-registered student's name will be treated as permanently withdrawn and will cancelled.
- viii. The decision of the Vice Chancellor regarding all aspects of admission, temporary withdrawal, deregistration, re-registration, admission cancellation, permanently withdrawal of students, interpretation of the rules/regulations and relaxation in the rules/regulations will be final and binding.

ix. This is applicable to all students irrespective of admission year.
